



# INDIAN FOREST SERVICE BENEVOLENT AND WELFARE TRUST

## DEED OF TRUST

This Deed of Trust made on this day of February 3, 2026 by **Mr. A K Goyal, S/o late Shri Banu Ram Goyal**, aged 69 years and resident of A1/406, Tower 6, Silver Estate, Sector 50, NOIDA, Uttar Pradesh, PIN: 201301.

**WHEREAS** the Trust known as "**INDIAN FOREST SERVICE BENEVOLENT AND WELFARE TRUST**" was originally constituted by a Deed of Trust executed on July 22, 2008 by **Shri A.N. Prasad** (Settler), **S/o Shri Girish Nandan Prasad** and the said Trust Deed was duly registered with the office of the Sub-Registrar, New Delhi, bearing Registration No. 3512, Book No. 4, for the year 2008-2009 having administrative office of the Trust at 1102, Kucha Natwa, Chadni Chowk, New Delhi-110006.

**AND WHEREAS** the said Trust was created as a public charitable trust with the primary object of (a) to provide financial assistance to the bereaved families of IFS officers who die in harness (b) to undertake any other activity for the welfare of family member of IFS officers as decided by the Trustees from time to time and the Settlor had settled a sum of Rs. 1,000/- (Rupees One Thousand only) as the initial corpus of the Trust;

**AND WHEREAS** at the time of establishment of the Trust, fourteen (14) **Founding Trustees** were appointed and pursuant to the provisions of the original Trust Deed, twelve (12) additional **Trustees** were appointed at the first meeting of the Trust held on August 04, 2008;

**AND WHEREAS** subsequent to the execution of the original Trust Deed, two Trustees, namely; Mr. K.B. Thampi, a Founding Trustee, and Mr. Nagabhushan Reddy Rao, a Co-opted Trustee, have passed away;

**AND WHEREAS** subsequent meetings of the Trust were held on August 22, 2008 and April 02, 2009;

**AND WHEREAS** due to various reasons, the activities of the Trust could not be pursued after 2009.

**AND WHEREAS** the Trustees in the meeting held on January 24, 2026 unanimously decided to widen the scope of the objects and purposes of the Trust to include officers and families of all other forestry field personnel, apart from the officers and families of the Indian Forest Service Officers, as beneficiaries, and to also update, clarify and

rationalise certain provisions of the Trust Deed, *inter alia*, relating to the composition and eligibility for induction of new Trustees, revised the governance structure, committees and their quorum, banking operations, administrative flexibility, and certain other provisions to align with the prevailing legal and regulatory requirements;

**AND WHEREAS** the Trustees, have unanimously, approved the amendments incorporated herein, being satisfied that such amendments do not alter the charitable nature of the Trust, nor defeat its original objects for which the Trust was created, and are necessary for the effective administration and continuation of the Trust;

**AND WHEREAS** clause 20 of the original Trust Deed dated July 22, 2008 expressly empowers the Board of Trustees to vary, alter, add to or delete the terms and stipulations of the Trust Deed, subject to the charitable character of the Trust being preserved and compliant with applicable laws;

**AND WHEREAS** at the fourth meeting of the Trust held on January 24, 2026 further eight Trustees were appointed in accordance with the criteria approved by the Board of Trustees;

**AND WHEREAS** at the time of the meeting of the Board of Trustees held on January 24, 2026, an amount of rupees 8, 50,795/- was available in the savings bank account of the Trust;

**AND WHEREAS** the Trustees now desire to formally record and give legal effect to the said amendments by registering this Amended Trust Deed, with the appropriate authorities including the office of the Sub-Registrar;



**3.** The name of the Trust shall be "**INDIAN FOREST SERVICE BENEVOLENT AND WELFARE TRUST**".

**4. Objects and Purposes:** The objects and purposes of the Trust shall be as follows:

- (a) To provide financial assistance to the bereaved families of officers and all other subordinate forestry field personnel including Indian Forest Service (IFS) officers, State Forest Service (SFS) officers, Forest Range officers, who die while performing their duties.
- (b) To provide financial assistance to officers and all forestry field personnel who suffer serious injuries, disabilities, or critical illnesses while performing their duties.
- (c) To undertake any other activity for the welfare of family members of officers and all other subordinate forestry field personnel, as decided by the Trustees from time to time.

**5. Application of Funds:** It is hereby declared that no part of Trust property or its income shall be applied for any purpose other than a charitable purpose, public utility and welfare of officers and families of Indian Forest Service Officers, State Forest Service Officers, Forest Range Officers, and all other subordinate forestry field personnel.

**6. Trust Fund:** That the aforesaid amount of Rs. 8,50,795/- (Eight lakh fifty thousand seven hundred and ninety five only) available in the account of the Trust together with all moneys and/or properties received by the Trust from time to time by way of





contributions, donations, gifts, grants, etc., from any persons in or outside the country including the Founder/Trustees or by the member of his/their families, institutions, societies, corporations, associations, local authorities or the Government and all accumulations thereof or accretions, thereto and all income arising there from and all properties owned or possessed by the Trust, shall constitute the " Trust Fund".

**7. Administrative Office:** The Administrative Office of the Trust shall be "Office of the Deputy Conservator of Forests, Department of Forests and Wildlife, Kamla Nehru Ridge, New Delhi -110007".

**8. Trusteeship:** The number of Trustees shall not be less than ten. The Trustees shall be appointed for their lifetime but any Trustee may resign by giving notice in writing to the other Trustees. In the event of a Trustee being of unsound mind and insolvent, he would cease to be a Trustee. The Trusteeship shall be limited to such members who are willing to take fiduciary, legal and governance responsibilities of the Trust.

**9. Appointment of Trustees:** In the event that any of the above-named Trustees dies, resigns, becomes unfit or incapable to act as such, or otherwise vacates his office for any reason whatsoever, the Board of Trustees may nominate and co-opt a suitable person as Trustee in place of the Trustee so died, resigned, became unfit or incapable, or vacated the office. Further, the Board of Trustees shall, from time to time, and based on such eligibility criteria, experience and suitability, as may be determined by the Board, nominate or induct additional Trustees as may be considered necessary for the efficient, smooth, and effective management of the affairs of the Trust and its Governing Body.

**10. Membership:** All serving and retired members of the Indian Forest Service shall be deemed to be members of the Trust and the membership shall be automatic and shall not require any formal application or approval.

**11. Contributions to the Trust Fund:** To accept donations, contributions including corporate social responsibility funds and proceeds of intellectual property rights, subscriptions, gifts and/or other grant-in-aid whether in money or in kind or any movable or immovable property from any person living in/outside India, or from any foreign individual/association/religion or cultural centre/temple based in any foreign country or institution, society, corporation, association (whether incorporate or not) local authority, Government and charitable institutions, either Indian or foreign, subject to relevant laws, rules and guidelines of the Government of India applicable in the matter, for the advancement of any of the objects and purposes of this Trust.





**12. General Management of Trust Funds and Properties:** The general management and control of the Trust funds and properties and its affairs shall be vested with the Trustees who shall have powers to do such acts as may be deemed necessary for the benefit of the Trust and/or management of its properties and affairs. The Trust may apply any part of the Trust fund to acquire, purchase, any movable or immovable properties, vary, sell, convert, change, self-mortgage, transfer, transpose, alienate or otherwise deal with all or any of the investments including investments in fixed deposit with any bank/financial institutions or in any scheme of the private/corporate or of the Government, in accordance with the provisions of applicable laws, rules and guidelines.

**13. Power of Amalgamation:** Trust will have powers to amalgamate the Trust with other institutions, associations or organizations having charitable objects and purposes.

**14. Appointment of Staff and Delegation of Administrative Powers:** To appoint assistant secretaries, managers and other employees on such terms and conditions including payment of monthly honorarium as the Trustees may in their discretion think proper and necessary for carrying out the management of the Trust and/or the Trust property, and to delegate to such assistant secretaries, managers or other employees any of the power of the Trustees for the general, or for the specified purposes as may be deemed expedient and proper for the convenience of the administration and/or proper for working of the Trust. The assistant secretaries or managers or other employees so appointed shall be responsible for keeping the records of the minutes of the meetings of the Board of Trustees, Governing Body and its Committees, and of the general working and administration of the Trust, subject to the supervision and control of the Trustees, and or any Trustee and/or any person authorised by the Trustees for the purposes; and

**15. Residual and Incidental Powers:** Generally, to do all acts, deeds and things as may be necessary for the proper management, control and administration of the Trust and/or the Fund and all other matters incidental thereto or connected therewith.

**16. Bank Accounts:** The Trust may open and maintain accounts with one or more Banks. The Board of Trustees shall authorize five (5) Trustees as signatories for operating the bank accounts. Any two (2) out of the five (5) authorized Trustees shall be jointly competent to operate the bank accounts. The Board may, by resolution, change the authorized signatories from time to time.

**17. Governing Body:** The Board of Trustees shall elect a Governing Body for a term of two years by a majority vote.

The Governing Body shall consist of:

- President – One
- Vice President – One
- Secretary – One
- Joint Secretary – One
- Treasurer – One
- Members – Ten

The Governing Body shall be responsible for the day-to-day management and administration of the Trust, subject to the supervision of the Board of Trustees.

**18. Meetings of the Trust:** The meeting of the Board of Trustees shall be held at least once in a financial year and notice of such meeting shall be served on the Trustees at least seven days prior to the time and date of holding the meeting. The Secretary, Governing Body shall convene the meetings of the Board of Trustees as well its Governing Body and issue notice of such meetings. In case the Secretary is not available, the President may authorise the Joint Secretary/Treasurer/or Vice President to convene the meeting and do all the needful actions necessary for conduct of the meetings. In the absence of the President, the Vice President shall preside over the meeting. In the absence of both the President and Vice President, the Trustees present shall elect a Trustee from among themselves to preside over that particular meeting. The Trustee presiding over the meeting shall have a second or casting vote in case of equality of votes on any matter.

**19. Ordinary and Special Meetings:** The Trust shall hold at least one ordinary meeting every year. Special meetings may be convened at any time by the President, Secretary, or any two Trustees upon giving at least seven clear days' notice specifying the matters to be discussed.

**20. Committees:** The Trust may constitute committees comprising one or more Trustees and other members for carrying out the objects and purposes of the Trust. The quorum for meetings of any such committee shall be more than thirty-three percent (33%) of the total members of that committee.

**21. Quorum:** The quorum for meetings of the Board of Trustees shall be eight and for the meetings of the Governing Body or a Committee shall be more than 33% of the total number of the membership of the Governing Body or the Committee. If quorum is not present within thirty minutes of the scheduled time, the meeting shall stand adjourned to the same day in the next week at the same time and place, or to such other day, time





and place as the person convening the meeting may determine. At the adjourned meeting, the members present shall form the quorum.

**22. Voting:** At the meetings of the Board of Trustees, Governing Body, or a Committee, every matter shall be determined by a majority of the members present and voting on the question provided that in case of equality of votes, the presiding Trustee of the meeting shall have a second or casting vote.

**23. Administrative expenses:** The administrative expenses incurred in connection with the day-to-day functioning of the Trust will be borne from the Trust Fund.

**24. Implementation of Resolutions:** All the resolutions adopted by the Board of Trustees and decisions taken by the Governing Body and a Committee shall be carried out by the respective Secretary/Joint Secretary as per the work responsibilities allocated.

**25. Legal Powers and Authority:** The Governing Body shall have powers to institute suits, actions and legal proceedings, to prefer appeals, to make applications or petitions, and to give affidavits, wherever necessary, and to defend or compound, compromise, abandon, submit to arbitration or otherwise settle any suit, action, claim, legal proceedings appeal, demand or dispute, relating to or connected with the Trust property or any part thereof and/or affairs of or relating to or connected with the Trust.

**26. Power to Appoint Attorneys to Delegate Powers:** To nominate, appoint and constitute attorney(s) legal practitioners, agent(s), etc., and to delegate all or any or the duties and powers vested in them (Trustees) with regard to the management of the Trust or the Trust property including starting or defending of legal proceedings or for opening or operating upon accounts with any banks persons or to do such other acts and duties relating to or connected with the Trust Property as may be deemed necessary.

**27. Income tax exemption:** That the Trust shall apply for exemption to the Income Tax Department under the relevant provisions of the Income Tax Act.

**28. Receiving foreign donations:** In the event of donations being received in foreign exchange, the Trust shall also register with the Government of India under the Foreign Contribution (Regulation) Act.

**29. Irrevocability of the Trust:** That the Trust hereby created is irrevocable.

**30. Acceptance of Trusteeship:** That the Trustees have accepted the Trust.






**31. Power to Amend:** The Trustees may by majority of votes vary, alter, add or delete any of the objects and purposes or terms and stipulations of the Trust Deed subject to the provisions that such amendments shall not:

- (a) change the charitable nature of the Trust;
- (b) violate any provisions of the Income Tax Act or other applicable laws;
- (c) defeat the original objects and purposes for which the Trust was created.

All other terms and conditions of the original Trust Deed shall remain unchanged and in full force and effect.
