This refers to the first meeting of the General Body of the IFSBWT. As you may know, the IFSBWT with its revised mandate has been constituted as a registered charitable entity under The Registration Act, 1908, in February 2026. Its primary mission is to provide financial support to all forestry personnel—particularly frontline staff and their families—in the event of critical injury or demise in the line of duty.

2. Besides the existing Board of Trustees—which comprises 32 serving and retired IFS officers—Clause 10 of the Trust Deed provides for all serving and retired IFS officers in the country to be included as 'Deemed Members'. A copy of the Trust Deed, dated February 11, 2026, outlining its constitution, objectives, and vision, is available in the "About Us" section of the Trust website www.foresttrust.in.

3. Established just three months ago with renewed mandate, the Trust has actively focused on building its foundational infrastructure—developing resources, creating outreach channels for donors and beneficiaries, and ensuring legal compliances. During this critical launch phase, the Trust also provided vital financial relief to the families of two Forest Guards who lost their lives in the line of duty.

4. In addition to reviewing the Trust's recent activities and milestones, this General Body meeting will focus on soliciting members' insights to help shape this institution's long-term sustainability. The virtual meeting will take place on **May 24th, 2026, at 19:00 hrs.** The joining link will be communicated separately and posted on the Trust website www.foresttrust.in.

Kindly disseminate this meeting invitation to all serving and retired IFS members in your State/UT as well as to the respective IFS Association, to ensure maximum participation at the General Body meeting of the Trust. Your help will go a long way in strengthening this institution, dedicated to supporting forestry personnel on the front lines of forest protection.
